


Wall Mount Assembly Components






Step 2 - Assemble the vertical pole






Lock D4 into the marked line position




Step 5 - Install the cable & Adjust the vertical position, distance & tilt

21 Adjust the vertical position of monitor





Height adjustment 10mm




Step 6 - Adjust the distance & tilt
